SUMMARY ANNUAL REPORT

FOR TEAMSTERS INSURANCE PREMIUM REIMBURSEMENT FUND

This is a summary of the annual report of the Teamsters Insurance Premium Reimbursement Fund, EIN 26-6704198, Plan No. 501, for period January 01, 2019 through December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Teamsters Insurance Premium Reimbursement Fund has committed itself to pay all claims incurred under the terms of the plan.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$575,109 as of December 31, 2019, compared to \$530,388 as of January 01, 2019. During the plan year, the plan experienced an increase in its net assets of \$44,721. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$82,827, entirely from employee contributions.

Plan expenses were \$38,106. These expenses included \$29,756 in administrative expenses, and \$8,350 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Teamsters Insurance Premium Reimbursement Fund, 8814 Fargo Road Suite 200, Richmond, VA 23229) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
